NATIONS MINISTRY HELPS REFUGEE FAMILIES BECOME GENERATIONALLY SUCCESSFUL THROUGH INTENSIVE SERVICES PROVIDED TO YOUTH THROUGH AFTER-SCHOOL AND SUMMER LITERACY PROGRAMS, SOCIAL-EMOTIONAL LEARNING SUPPORTS, A SEVEN-WEEK SUMMER READING PROGRAM, CASE MANAGEMENT, AND PARENT WORKSHOPS ON EDUCATION OPPORTUNITIES. THIS YEAR THE PROGRAM SERVED A TOTAL OF 154 CHILDREN FROM 18 ETHNIC IDENTITIES. ON AVERAGE, EACH CHILD IMPROVED 3.3 LEXIA READING LEVELS AND 87% OF CHILDREN IMPROVED IN AT LEAST ONE SOCIAL-EMOTIONAL COMPETENCY. SIXTY-ONE STUDENTS RECEIVED 761 HOURS OF VIRTUAL ASSISTANCE. OUR DEPARTMENT OF JUSTICE-CERTIFIED IMMIGRATION SERVICES ASSISTED 377 PEOPLE IN APPLYING FOR US CITIZENSHIP, GREEN CARDS, AND OTHER BENEFITS. OUR ELDER SERVICES PROGRAM SERVED 46 ZOMI AND NEPALI ELDER SERVICES AND FULFILLED 240 SERVICE REQUESTS WHICH YIELDED OVER \$35,807 IN ECONOMIC BENEFIT. IN ADDITION TO OTHER SERVICES, WHEN COVID STARTED, WE BEGAN PROVIDING APPLICATION SUPPORT TO FAMILIES APPLYING FOR PROPERTY TAX GRANTS TO HELP WITH THE INCREASE ON THEIR PROPERTY TAXES.
