THIS YEAR THE PROGRAM SERVED 126 CHILDREN AND YOUTH RECEIVED 19,414 HOURS OF INSTRUCTION. USING AN ONLINE PROGRAM WHICH PROVIDES INDIVIDUALIZED READING INSTRUCTION, YOUTH ADVANCED 2.97 LEXIA LEVELS (18 LEVELS TO FIFTH GRADE READING LEVEL). 72 CHILDREN IMPROVED AT LEAST ONE READING GRADE LEVEL.
